

There is also a contact list for startups which can direct you to sources of capital you may not know of (local angel networks, crowdsourcing, local startup bootcamps) and how they work. That said, this will not provide every single answer you need from incroporation through IPO. For that, no single book will. But maybe with 60 or 70 different books and a team of lawyers and bankers, you can start to scratch the surface. It's a starting point and reference guide to keep on hand through the process.

If you are thinking about or in the process of building or starting a business and have to raise outside funds, this book is for you. The author, Andrew Sherman, assumes he is speaking to an intelligent reader unlike many books I bought on this topic. I just ordered another copy of this book for my father-in-law, who is thinking of expanding his small printing company.
