

But it does contain a wide variety of interesting insights into the world of the new globalized elite, citizens of no country who completely lack positive feeling and loyalty towards their native lands. These insights are the bookâ <sup>™</sup>s real value.I ordered this book when I read an article on Harringtonâ <sup>™</sup>s research in The Atlantic. She is a professor of sociology. When deciding to focus on wealth management, she early identified that the profession was insular, secretive, and not likely to have its practitioners give up its knowledge to an academic who contacted its members out of the blue. Therefore, she went to the trouble of obtaining what is â œthe accepted global standard for practitioners, the TEP, or Trust and Estate Planning certification,â • issued by the London-based Society of Trust and Estate Practitioners (STEP). TEP is a â œtwo-year wealth management training program,â • which she earned under her own name, not concealing her purpose of publicly analyzing the wealth management profession. Through this, she both learned the details of wealth management, and, more importantly, met and was able to get to know and interview numerous individuals around the world who earn their living in wealth management (who are quoted using pseudonyms). This is a very impressive accomplishment and gives the reader a high degree of confidence in the book.
